Monica Pagdato first applied for Vocational Rehabilitation Services in 2017 while still in high school. At the time, Monica was shy and struggled with speaking to others. She knew that in order to succeed, she needed to build her self-confidence and learn how to advocate for herself.

After graduating from high school, Monica enrolled at Northern Marianas College. Although she took several college classes, she eventually decided to take a break from her studies to explore the workforce. With the support of her instructors and classmates, Monica worked hard to pass her college courses. However, she felt a strong desire to gain practical work experience.

Thanks to her Vocational Rehabilitation Counselor, Ms. Jane Tudela, Monica secured Work Experience Training with the Division of Revenue and Taxation. From March 2021 to June 2021, she worked as a trainee, gaining valuable hands-on experience. Following that, Monica continued her growth with On-The-Job Training from September 2021 to March 2022.

Monica's supervisor praised her work ethic, and with further assistance from the Workforce Investment Act (WIA), Monica received additional training to continue improving her skills. As a result, her job training extended for another year. In October 2024, Monica was hired as a full-time Revenue Taxation Trainee at the Division of Revenue and Taxation.

Throughout her journey, Monica learned valuable strategies to help her focus on tasks and not worry about making mistakes. She appreciated the consistent guidance and encouragement from her Vocational Rehabilitation Counselor. Monica also gained confidence by collaborating with her classmates in college and her colleagues at work.

Her advice to others? "It's okay to make mistakes and not worry about them; you'll learn from them. Don't be afraid to ask questions if you don't understand the task."
