WHO WE ARE: **OUR MISSION**

The mission of the CNMI Office of Vocational Rehabilitation is to INCREASE EMPLOYMENT and **PROMOTE INDEPENDENCE** eligible among individuals with disabilities throughout the Commonwealth of the Northern Mariana Islands.

OUR PROGRAMS AND SERVICES

BASIC SUPPORT/SUPPORTED EMPLOYMENT (BS/SE) PROGRAM

The Basic Support/Supported Employment (BS/SE) Program provides qualified individuals with disabilities the necessary supports they need in order to successfully achieve their employment and vocational goal(s). The BS/SE program likewise provides various training opportunities through the work-experience training (WET) program and on-the-job training (OJT) program, as well as job search placement, counseling and guidance and other services that may be deemed necessary to successfully achieve and/or maintain the individual's employment goal.

PRE-EMPLOYMENT TRANSITION SERVICES (PRE-ETS) PROGRAM


The Pre-Employment Transition Services (Pre-ETS) Program provides students with disabilities, ages 16-21, transition services to help prepare them for life after high school. This is achieved through its five-core services: Job Exploration Counseling, Work-Based Learning Experience, Counseling on Post-Secondary Education, Work-Readiness Training, and Instruction on Self-Advocacy.


INDEPENDENT LIVING FOR THE OLDER BLIND (ILOB) PROGRAM


The Independent Living for the Older Blind (ILOB) Program provides individuals, ages 55 and older, and with severe visual impairments (corrected vision in the better eye is 20/70 or worse (al least low vision)), with a desire to be able to live independently. The ILOB Program provides a variety of low-tech to high-tech assistive technology that can assist the individual in his/her daily living activities.



ACCOMPLISHMENTS & IDENTIFIED CHALLENGES

WHAT WE HAVE ACCOMPLISHED

- CNMI OVR hosted the 2021 National Disability
 Employment Awareness Month (NDEAM) at the beginning of the fiscal year
- Established relationships with various partners and community stakeholders through business engagements and school outreach efforts
- Last June, the WIOA Tri-Agency Modified State Plan was approved by our grantor agency, the RSA
- CNMI OVR participated in several community service efforts such beach clean-ups and bus stop rehabilitation projects.

OUR CHALLENGES

- Locating full-time employment opportunities for our consumers with disabilities continues to be an existing challenge post-COVID-19 pandemic
- Short-staffing issues were experienced throughout the year for specialized positions such as Admin and Operations Specialist, Employment Specialist, VR Counselors/Aides
- Finally, one of the biggest challenges we had experienced this year was the delay in receiving our federal allotment.


